From George Washington Bridge:

Palisades Interstate Parkway North to Exit 9W (NYS Thruway North). Take Exit 14 (Spring Valley/Nanuet) and make left at light onto Route 59 East. At first traffic light, make right onto Old Turnpike Way. Follow curve in road and make right into Town House Office Park. Continue straight through complex and make right at second driveway. Our office is located in the building marked 501-504.

From New Jersey:

Route 3 or Route 46 to Garden State Parkway North to New York State Thruway and bear right at fork ("To New York"). Stay on Thruway to Exit 14 for Spring Valley/Nanuet. At first traffic light, make right onto Route 59 West. At next traffic light, make left onto Old Turnpike Way. Follow curve in road and make right into Town House Office Park. Continue straight through complex and make right at second driveway. Our office is located in the building marked 501-504.

From Westchester County Airport:

Main Terminal to traffic light to Interstate 684 South to Route 287 West (Cross Westchester Expressway) to Tappan Zee Bridge. Follow Rte. 87N (NYS Thruway) to Exit 14 (Spring Valley/Nanuet) and make left at light onto Route 59 East. At first traffic light, make right onto Old Turnpike Way. Follow curve in road and make right into Town House Office Park. Continue straight through complex and make right at second driveway. Our office is located in the building marked 501-504.

From LaGuardia Airport:

Grand Central Parkway West to Triboro Bridge. Major Deegan North to New York State Thruway North to Tappan Zee Bridge to Exit 14 (Spring Valley/Nanuet) and make left at light onto Route 59 East. At first traffic light, make right onto Old Turnpike Way. Follow curve in road and make right into Town House Office Park. Continue straight through complex and make right at second driveway. Our office is located in the building marked 501-504.

From Orange County:

Palisades Interstate Parkway South to Exit 9W - NYS Thruway North. Take Exit 14 (Spring Valley/Nanuet) and make left at light onto Route 59 East. At first traffic light, make right onto Old Turnpike Way. Follow curve in road and make right into Town House Office Park. Continue straight through complex and make right at second driveway.
